He is an internationally recognized academic in entrepreneurship, serving for almost two decades on the Faculty of Manchester Business School - University of Manchester (UK) as Fellow in SME Management, Senior Lecturer in Entrepreneurship and Visiting Associate Professor for Family Business Initiatives. He lectures, educates, researches, advises and consults internationally on entrepreneurship and strategic development of family businesses and businesses families. Professor Poutziouris is former President of IFERA (International Family Enterprise Research Academy), Fellow of Family Firm Institute (USA); country expert on family business and entrepreneurship policy matters, working with OECD, European Commission and other stakeholder organizations.
